THE CRIMINAL JUSTICE SYSTEM

As its title suggests, this course will focus on aspects of the criminal justice system in the United States. More specifically, in the first half of the semester we will examine the definitions of various crimes. In the second half we will examine various procedural aspects of criminal justice.

TEXTS (also ordered through Iowa Book and Supply, 8 S. Clinton)

- Scheb and Scheb, Criminal Law and Procedure, 8th ed. (7th or 6th eds. are okay)
- Gifis, Law Dictionary, 7th ed. (6th ed. or other law dictionary is okay)
- Strunk and White, *The Elements of Style*, 4th ed.
- Bugliosi, *Helter Skelter* (recommended)
- Taylor and Johnson, Until Proven Innocent (recommended)

Scheb and Scheb will be the primary text for the course. The coursepack (see below) contains additional cases. Bugliosi's *Helter Skelter* is an excellent examination of the process from commission of the crime to final sentencing. Taylor and Johnson's *Until Proven Innocent* is an example of a failure of the system. The other required books (Gifis, Strunk and White) are intended for reference purposes. Those unfamiliar with legal writing and terminology will find many new terms and a legal dictionary will help you learn them. One of the requirements of this course will be a paper (the specific assignment will be given later). A clear, concise, and error-free writing style is essential. Strunk and White, or other style manuals, will provide you with a review or introduction to many of the basics of good writing.

ON RESERVE (Reserved Reading Room, Main Library)

All the books listed above and some additional books have been placed on reserve at the Reserved Reading Room in the Main Library. I will discuss my recommendations regarding these books during the first class period.

CASES COURSEPACK (available on ICON)

The coursepack contains several Supreme Court cases to be read along with the chapters in the second half of the course.

OTHER "COURSEPACK" (available on ICON)

This "coursepack" consists of several handouts and other information including the value systems of the justices, general requirements for the paper assignment, tips on how to take my multiple choice tests, and an extensive list of study questions.

GRADING

Grades will be based on the following:

- *Two multiple-choice exams* (70%). The first test (30%) is tentatively scheduled for Tuesday, March 5, and will cover material through Chapter 14. The second test (40%) will be during the regular final exam period announced later, but it will primarily cover material from the second half of the semester.
- *A paper* (30%). General requirements for writing the paper are contained in the coursepack. Specific details of the assignment will be given to you the class period following the first exam, but no later than Thursday, March 7. Nevertheless, you should read Strunk and White and the *Style Manual for My Courses* on ICON as soon as possible. You should familiarize yourself with these requirements before the paper assignment is handed out. The paper will be due at the beginning of class on Thursday, April 4.

Based on your performance on the assignments (two tests and paper), you will be assigned a grade according to the following 100-point scale:
